ITEM 2: EDUCATIONAL BACKGROUND AND BUSINESS EXPERIENCE

Alan Hartley, CFA is managing member and owner of Black Cypress Capital Management, an investment firm based in Ponte Vedra Beach, FL. He is also a Board Member of the University of North Florida (UNF) Foundation and is currently Chair of the Foundation's Endowment Investment Committee.

Mr. Hartley also holds the Chartered Financial Analyst (CFA) designation. In order to be granted the right to use the CFA designation, an individual must first complete a combination of four years of college education or qualified, professional work experience and pass three, six-hour examinations covering ethics, investment management, economics, and other investment-related topics.

Alan began his investment career in 2005 as a research associate at Ergates Capital, a Jacksonville, FL-based long/short hedge fund. Next, Alan joined Morningstar as a generalist equity analyst where he covered thirteen different industries and was promoted to the IPO team. From 2006 to 2009, Alan managed \$50 million in AUM on the behalf of six different investment advisors at F&S Asset Management Group. Alan launched Black Cypress in June 2009. Alan graduated from UNF in 2005 summa cum laude and received a B.B.A. in Finance. He currently lives with his wife, son, and two daughters in Ponte Vedra Beach, FL. Mr. Hartley was born in 1982.

ITEM 3: DISCIPLINARY INFORMATION

Alan Hartley entered into a Stipulation and Consent Agreement with the State of Florida on July 16, 2021 to resolve findings that Mr. Hartley rendered investment advice, from a location within the state of Florida, without being registered by the Office as an associated person of a federal covered adviser. The findings were the result of an erroneous Form U5 filed by an independent compliance consultant hired by Black Cypress, and therefore, Mr. Hartley was unaware of the inadvertent withdrawal of his Florida registration between June 23, 2020 and March 4, 2021. Mr. Hartley has been registered in the State since 2009.
